- 5. The project must be completed within one year of grant approval.
- 6. RC&D makes a mini-grant award in good faith and is not responsible for negligence, misconduct, or negative consequences of the use of RC&D mini-grant funds by the awardees. The awardee will hold RC&D harmless and indemnify from any claims or litigation for injury, death, or damage to person or property caused by the awardee's performance of the project.
